Dear Ms. Patty Overley,

The following is in response to your California Public Record Act request dated June 1, 2021.

(1) “All text message communications sent or received by a particular City employee on May 26, 2021, between the hours of 6:00pm until the adjournment of the Planning Commission meeting.” The text messages that are responsive to this request, which constitute public records are attached. The text messages that do not refer to City business because they are personal and non-disclosable or identify the names or photos of family members have been redacted – see Government Code §6252(e).

(2) “All email communications sent or received by a particular City employee on May 26, 2021, between the hours of 6:00pm until the adjournment of the Planning Commission meeting” – We have provided the responsive documents. We have also provided responsive electronic communications similar to email. The electronic communications that do not refer to City business have been redacted – see Government Code §6252(e).

(3) “[A]ll the communications that went through the WebEx chat feature during the May 26, 2021 Planning Commission meeting; 5:30pm until the adjournment of the that meeting” – We have provided the responsive document.

With respect to the text messages referenced above in response to request no. 1, it is unfortunate that the employee used a personal mobile device to communicate with a family member during the meeting for communications related to the public’s business.

We deeply regret that this happened. This does not reflect the respect for the public to which the City is committed. As we look to transition away from virtual public meetings and welcome people back for in-person meetings, the City of Ventura remains committed to the highest level of public service, including respect for the public.
